² Maximum of 6 free electronic/automatic transfers per month for Savings accounts per Government Regulation D. Government Regulation D places a limit of six withdrawals or outgoing transfers per month from savings or money market accounts via several transaction methods. "Transactions counted against the limit include preauthorized or automatic transfer, or telephonic (including data transmission) agreement, order or instruction, or by check, draft, debit card, or similar order made by the depositor and payable to third parties. Transactions not counted against the limit include mail, messenger or in person or when such withdrawals are made by telephone (via check mailed to the depositor)."
